Thousands of people crowd by the banks of the Kocha River, a branch of the Sandhya River, at Harta Union under Wazirpur Upazila in Barisal on Laksmipuja to enjoy the traditional boat race. Teams of professional boatmen participate in the traditional race with boats from different regions decorated in different colors. The boat race becomes a meeting place for hundreds of people from nearby upazilas, including Agailjhara, Gournadi, Swarupkath (Nesarabad) and different parts of the district.
